IV. FIRST AID MEASURES:

EYE CONTACT: Irritating to eyes. Immediately flush eyes with large amounts of water for at least 15 minutes while holding eyelids open. Transport to the nearest medical facility for additional treatment.

SKIN CONTACT: Repeated exposure may cause skin dryness or cracking. Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. Call a physician if irritation persists.
