Steps to be Taken in Case Material is Released or Spilled:  
SMALL SPILL: ABSORB SPILL WITH AN INERT MATERIAL (E.G., DRY SAND OR EARTH), AND THEN PLACE IN A CHEMICAL WASTE CONTAINER.  
LARGE SPILL: CONTAIN SPILLED PRODUCT WITH INERT MATERIAL. CLEAN AREA AS APPROPRIATE SINCE THE PRODUCT MAY PRESENT A SLIP HAZARD. FINAL CLEANING MAY REQUIRE USE OF STEAM, SOLVENTS OR DETERGENTS.
